#### 1. Academic ethics and prevention of plagiarism

The study process must adhere to the principles of academic ethics, which are often violated by plagiarism in study papers. Plagiarism is using the words or ideas of others without giving them credit and presenting them as your own. Incorrect citation, when a source is misidentified can also be considered as a violation of academic ethics.

Common types of plagiarism:

- Giving the text directly word for word of others without quotation marks;
- Paraphrasing or quoting an author directly without citing the source.

To avoid plagiarism, it is necessary to properly identify all sources used in the paper and provide them in accordance with the prescribed citation requirements. The APA (American Psychological Association) citation style is used at Vilniaus Kolegija for all study papers and graduation theses, adapted to study papers' standards of Vilniaus Kolegija and the Lithuanian language grammar rules.

**Important!** Dishonesty cases, such as plagiarism, copying, making money on writing a paper for other students, buying a paper work and giving it in to the member of the academic community for assessment must be announced to the ethics Committee. Possible sanctions for non-ethical conduct include: personal or public warning, disciplinary penalty set in the laws of the Republic of Lithuanian or the documents governing the study procedures of Vilniaus Kolegija.

#### 2. Citing in the text and crediting sources

While preparing study papers, various sources of information are studied and analysed, ideas, methods and research data found in them are used in order to reveal the research topic as thoroughly as possible. Information can be cited in several ways: you can quote the source directly or paraphrase, summarise the text.

**Direct quote** – reproducing the text directly word for word of another author's work. When giving a direct quotation, enclose the quotation with double quotation marks, always provide the author's surname (if there is no author, provide the title of the source), the year and the page of the citation. The surname of the author, the date of the cited source can be as part of a narrative or placed in parentheses at the end of the quotation with the page of the direct quote. If there are no pages (e.g., webpages and websites, video, some ebooks or other publications), instead page provide other location information, e.g.: paragraph number, heading or section name, heading or section name with paragraph number, time (for audiovisual works, e.g.: (Widmaier, 2022, 3:15).

**Important!** Direct quotations should be used sparingly. The text of direct quotation cannot be changed, it must be exactly the same as it appears in the original source, including punctuation.

If a quotation is longer than 40 words, it should be presented as a block quotation on a new line (without quotation marks) 1.27 cm from the left margin. If some text places (words, sentences) have been omitted from a quoted passage, use ellipses in pointy brackets <...>.

#### **Direct quotation examples:**

According to Glanville (2019, p. 149), "information specialists typically work in a Boolean world"...

"Information specialists typically work in a Boolean world" (Glanville, 2019, p. 149).

In 2019, Glanville pointed out "information specialists typically work in a Boolean world" (p. 149).

"Information specialists typically work in a Boolean world. Search construction in database interfaces such as Ovid, EBSCOhost and ProQuest have historically used Boolean logic <...>. This approach retrieves records based on the presence or absence of terms" (Glanville, 2019, p. 149).

**Paraphrase** – writing information from another author's work in your own words, without changing the meaning of the original text. Paraphrase is one of the most often used citing ways, when you analyse and summarize the ideas of one or several sources. When citing paraphrased information, include the author and the date, the page is not required.

#### **Paraphrase examples:**

Original	Paraphrase
Companies sharing information about their products	Social media advertising is the way to reach
or service on Facebook, Twitter and Instagram can	your target audience fast (Author, 2018).
quickly reach potential customers.	

When paraphrasing, the author and the date can be listed in the text or placed in parentheses at the end of the sentence or the paragraph. Such words as: *according to, found, suggested that, contradicted, analysed and etc.* can help to mention the author in the sentence.

#### **Examples:**

Profit is not the most important effectiveness indicator of performance (Druker, 2009).

Research by Louch (2017) suggest that the ethics of financial institutions....

Kenneth and Traver (2019) study found ...

The cited author's surname must be given in the original language, in the language that is provided in the reference list, e.g., Velasquez, Горяев, Navrátilová.

**Important!** Each reference cited in the text must be included in the reference list, and each entry in the reference list must be used in the text.

# 2.1. In-text citation rules

One work by one author

(Velasquez, 2021) or Velasquez (2021)

One work by two authors

(Kenneth & Traver, 2019) or Kenneth and Traver (2019)

#### One work by three or more authors

(Miller-Nobles et al., 2018) or Miller-Nobles et al. (2018)

# Groups (government agencies, associations, corporations) as authors

First citation: (National Institute of Justice [NIJ], 2018) *or* National Institute of Justice (NIJ, 2018) Subsequent citation: (NIJ, 2018) *or* NIJ (2018)

• Use the abbreviation in the second and subsequent citations.

#### Works with no identified author

The book *Healthy mind* (2017).

Article "Sustainable organization" showed (Business, 2018).

• If a work has no identified author, cite in text the first 2–5 words of the title and the year. Use double quotation marks around the title of the article, the chapter or the web page and italicize the title of the periodical, the book or the report.

# Authors with the same surname

(J. Johnson, 2017), (L. Johnson, 2015).

• Citing authors with the same surname include the author's initials in all text citations.

# Two and more works by different authors

(Kenneth & Traver, 2019; Matsumura, 2018; Ramanna, 2020)

• List the authors in alphabetical order.

# Two and more works by the same author

According to Trevino research (2018a)

(Kaptein, 2019a, 2019b).

• Works by the same author with the same publication date must be identified by the suffixes *a*, *b*, *c* and so forth, after the year. The suffixes must be assigned in the reference list also.

# Law

## Secondary sources

Secondary sources citation – second-hand information from other researchers. Use secondary sources when the original work is not available through usual sources (from library, data basis). Citing in text, name the original work, write "as cited in" and give a citation for the secondary source. Give the secondary source in the reference list.

# Example:

Stevenson, Taylor and Knox "avoided using 'care' as a concept as it was found to be too diffuse to define within the context they were interested in" (as cited in Stansfield, 2019).

• Use double quotation marks, only when giving a direct quotation, when paraphrasing a secondary source – do not use it.

Important! Use secondary sources sparingly, only when the original work is unavailable.

# Figures

There are many different types of figures: diagrams, graphs, charts, photographs, images and etc. Any figure is protected by copyright and according to the Republic of Lithuania Law on Copyright and Related Rights (1999), without the authorisation of the author of a work, the figure is permitted to be reproduced only for a non-commercial purpose of illustration for teaching or scientific research, indicating the source and including the author's name. Include the source reference after the title of the figure and include the page, where it was published.

It is recommended to make your own figures or to revise and combine other author's figures with something of your own. When the figure is changed and supplemented, include "Adapted from" before the source.

If you have created your own original figure, include "Created by author according to" after the title and give the credit to sources. If no sources were used, include "Created by author".

#### 3. Reference list

The reference list of a study work must include all sources cited in the text, and all entries in the reference list must be cited in the study work text. Include the reference list at the end of the study work before the appendixes.

**Numbering**. Start the reference list on a new page and number with Arabic numbers. Set **1,5 pt space** within and between all reference entries.

**Order of references.** List references in an alphabetic order by the surname of the first author, if there is no author – order by title. Sources in the Latin alphabet are listed first, followed by the sources written in the Cyrillic alphabet, e.g., in the Russian language. Provide references in the original language of the source you are using.

If the author is unknown, alphabetize the references by the first (main) title word, not by the articles (*a*, *an*, *the*, *der*, *die* and etc.).

When arranging several works by the same author, order them by the year of publication, from the earliest to recent, e.g.: 2010, 2015, 2018 and etc.

**Several works by the same author published in the same year** are identified by **placing lower case letters** *a*, *b*, *c* and so forth – after the year of publication, e.g., Longo, V. (2019a).

If the same author is one of multiple-authors, precede one-author entries and then arrange multiple-author entries alphabetically by the surname of the second or, if the second author is the same, the surname of the third author, and so on:

- 1. Martinson, J. (2015)
- 2. Martinson, J., & Saigon, V. (2016)
- 3. Martinson, J., Smith, R., & Thomson D. (2016)
- 4. Martinson, J., Smith, R., & Walson, R. (2018)

While writing a thesis or other paper, it is recommended to use citation management tools, e.g: *RefWorks, Zotero, Mendeley, Endnote* and etc. These tools allow to import references from databases and repositories, organize and manage citations, choose citation style, create in-text citations and automatically create a reference list.

**Important!** However, it is always important to check out the reference list created by these tools (sometimes mistakes do occur) and correct all mistakes "by hand".

Reference list example is illustrated in 3 appendix.

#### 3.1. Books

According to APA (7th ed.) a reference style rules books and book chapters reference include: the author of the book, the publication year, the title of the book (italicize) and the publisher. Capitalize only the first word of a title and of a subtitle (if present). Giving a reference of the **electronic books** include the same elements, in the same order as printed and additionally add the book DOI number (DOI - digital object identifier) at the end of the reference list entry, if there is no DOI - add the URL.

• Join the final name by an ampersand "&".

# **Twenty-one or more authors**

• Include first nineteen author's names, then insert an ellipsis and add the final author's name.

• If the author and the publisher are the same, there is no need add publisher to avoid repetition.

• The editor is listed as the author with the abbreviation "Ed." after his name, or "Eds." if there is more than one editor.

# Book chapter, conference proceedings published as a book chapter

• If the chapter comes from a book where each chapter is written by different authors, then provide a reference for the chapter that you used. Invert the chapter author's name (first write initials, then surnames) and **chapter title** (**do not italicize**). The name of the book editors should be preceded after the chapter title by the word "In", put the comma and **italicize the title of the book**, provide chapter page numbers.

#### **3.2.** Periodicals

According to APA (7th ed.) a periodicals' (journals, newspapers, magazines) reference include: the author of the article, the publication date, the title of the article (do not italicize), the periodical title in full, the volume number, the pages of the article.

**Italicize** the **title of the article** and the **volume number**. Include the issue number (if available) in parentheses immediately after the volume number, do not italicize it. Give the periodical title in an uppercase and lowercase letters. Giving the pages of the article do not include "p".

Giving the reference of **the articles from electronic periodicals** include the same elements, in the same order as printed and add the article DOI number at the end of the reference list entry, if there is no DOI - add the URL.

Invert the authors of the article according to the same rules as referencing books.
